To Study how and why does the Quality of Life differ between the Diagonal Mar and La Mina districts of Barcelona.


Key Questions

 - How, if at all, can Geographical Models explain the differences?
 - How, if at all, has urban regeneration schemes/development plans affected the quality of life in the two districts?

2. INTRODUCTIONS

2.1 Defining quality of life

For a residential district, the quality of life is dependent on several factors illustrated in **Diagram 1.1**. A community that offers as much of these factors as possible can often provide the optimal quality of life, and is therefore pleasant and attractive to live in.



2.2 Background of Diagonal Mar

As a post-industrial city, Barcelona may be subject to urban fragmentation in a way similar to that of Los Angeles, where the population is polarized into rich and poor. Diagonal Mar Park may represent the city's rich – an American style gated residential community located on the city's southeast coast (location shown in **map 1.1**) that is currently the city's largest redevelopment site. Diagonal Mar is designed to attract Barcelona's young professionals stereotyped as the

"Yuppies", and as a gated community, it is expected to have specific impacts on the neighborhood, as listed in **Table 1.1** below.

2.3 Background of La Mina



La Mina is one of Barcelona's "poor" districts, known as a sink-estate of social deprivation, introversion and a mini-state of the Gitanos (who occupy 35% of local population).

Until late 1960s, La Mina was little more than an area of cultivated field close to the old industrial core on the coast (location see **map 1.1**). The area was eventually built up to provide low rent housing for itinerant workers from less developed parts of Spain (e,g. Andalucía). Since then, the area has divided into the Old Mina and the New Mina, the reasons explained in **Table 1.2**.

Today, after 45 years, one would expect La Mina to have developed well-balanced residential community However, this is not the case. The area is infamous with newspaper headlines (like that attached in the Appendix), featuring: "La Mina, district without law."

The construction of Diagonal Mar adjacent (500m) to La Mina is part of Barcelona's tradition of using investments to bring about social regeneration. It would be interesting to see, therefore, if the construction Diagonal Mar influenced the quality of life in both areas, and if not, why not.
